ARTICLES OF INCORPORATION OF

FOREST COVE HOMEOWNERS' ASSOCIATION, INC.

The undersigned, acting as incorporator of a corporation under the non-profit Corporation Act of the State of Florida, adopts the following articles of incorporation.

ARTICLE I - NAME

The name of the corporation is FOREST COVE HOMEOWNERS' ASSOCIATION, INC.

ARTICLE II - DURATION

The corporation's duration shall be perpetual.

ARTICLE III - PURPOSES AND POWERS

The purposes for which the corporation is organized are:

- A. To operate the Forest Cove Homeowners' Association and to undertake the performance of, and to carry out the acts and duties incident to the administration of the Forest Cove Homeowners' Association in accordance with the terms, provisions, conditions, and authorizations contained in these Articles, the By-laws of the Forest Cove Homeowners' Association, and the Declaration of Covenants, Conditions and Restrictions of Forest Cove recorded among the public records of Seminole County, Florida;
- B. To carry out the duties and obligations given by the Declaration of Covenants, Conditions and Restrictions of Forest Cove recorded among the public records of Seminole County, Florida; and
- C. To establish By-Laws and Rules and Regulations for the operation of the Forest Cove Homeowners' Association and to provide for the formal administration of the Forest Cove Homeowners' Association, and to enforce the Declaration of Covenants, Conditions and Restrictions of Forest Cove recorded among the public records of Seminole County, Florida, the By-laws of the Forest Cove Homeowners' Association, and the Rules and Regulations of the Forest Cove Homeowners' Association.

ARTICLE IV - MEMBERSHIP

The qualifications for members and the manner of their admission shall be regulated by the Declaration of Covenants, Conditions and Restrictions of Forest Cove recorded among the public records of Seminole County, Florida, and the By-laws of the Forest Cove Homeowners' Association.

ARTICLE V - REGISTERED OFFICE AND REGISTERED AGENT

The initial street address of the initial registered office of the corporation is 235 South Maitland Avenue, Suite 216, Maitland, Florida 32751, and the name of the initial registered agent at such address is Berry James Walker, Jr.

ARTICLE VI - MINIMUM NUMBER OF DIRECTORS

The initial board of directors shall consist of at least three members, who need not be residents of the State of Florida.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

The names and addresses of the persons who shall serve as directors until the first annual meeting of members, or until their successors shall have been elected and qualified, are as follows:

ARTICLE VIII - OFFICERS

ARTICLE X - BY-LAWS

The By-laws of the Forest Cove Homeowners' Association shall be adopted by the initial Board of Directors. The By-laws may be amended in accordance with the provisions thereof, except that no portion of the By-laws may be altered, amended, or rescinded in such a manner as it will prejudice the rights of Forest Cove at Sanford Farms, Ltd., a Florida limited partnership, or Mortgagees of real property located within the Forest Cove subdivision as described in the Declaration of Covenants, Conditions and Restrictions of Forest Cove recorded among the public records of Seminole County, Florida.

ARTICLE XI - AMENDMENTS TO ARTICLES

These Articles may be amended in the manner provided for under Florida Law and the By-laws of the Forest Cove Homeowners' Association.
