**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

**ARTICLE I**

**Name**

**ARTICLE III**

**Purpose(s)**

The specific purposes for which the corporation is organized are:

1. To offer non-academical Christian theological education and conduct biblical seminars on a weekly basis.
2. To teach and train reverends, pastors, evangelists, ministers, missionaries, chaplains and any individual who is serving, or would like to serve in the Christian ecclesiastical field or ministry focused on preaching the Christian Gospel.
3. To offer non-academical theological exams, evaluations and certifications by mail to clergies and individuals serving in the Christian ecclesiastical field or ministry focused on preaching the Christian Gospel.
4. To provide emergency food and/or clothes to the homeless within the nearby community as part of our training for new missionaries.
5. To conduct recreational activities such as educational and spiritual retreats, sports, field trips, camping trips, picnics, hiking, and fishing for the students of the institute.

### **Manner of election of directors.**

The method of election of directors shall be stated in the bylaws of this corporation.

## **ARTICLE V**

### **Limitation of corporate powers**

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

Institute of Theological Education, Inc., is to have the power to do any and all things necessary or expedient for carrying out the purposes of this corporation, and in general to possess all rights, privileges and immunities, and to enjoy all the benefits granted to corporations of similar characters under the laws of the State of Florida. These powers shall include, but not be limited to:

1. Erect, purchase, enter into a lease agreement, and maintain and upgrade, church buildings, social halls, business offices, and such other structures deemed necessary to carry out the overall purposes of this corporation.
2. Collect, solicit, and accept funds, gifts and other subscriptions necessary to purchase, lease and maintain all facilities used for the stated purposes of this corporation as a nonprofit organization.
3. Conduct all other powers necessary to carry out the general and specific purposes of the corporation.
