**ARTICLES OF INCORPORATION  
FOR  
RADIO BROADCASTERS ALLIANCE OF TAMPA BAY, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**  
**NAME**

The name of this corporation is Radio Broadcasters Alliance of Tampa Bay, Inc..

**ARTICLE II**  
**ADDRESS**

The principal place of business and mailing address of this Corporation shall be:

400 North Ashley Drive, Suite 2300  
Tampa, Florida 33602

**ARTICLE III**  
**PURPOSE**

The purpose for which this corporation is organized is for the promotion of radio broadcasting and the increase of radio broadcasting service to the communities of the bay area.

**ARTICLE IV**  
**MEMBERS**

(a) The members of this corporation shall be radio stations serving communities in the Tampa Bay Area.

(b) Members of this corporation shall be admitted to membership by application and acceptance by the membership.

(c) This corporation shall issue no stock. No part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in these articles. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of

statements. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(6) of the Internal Revenue Code or the corresponding provision of any future United States internal revenue law, or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law. On the dissolution of this corporation, the board of directors shall dispose of all of the assets of this corporation in the manner or to the organization or organizations that qualify as exempt organizations under Section 501(c)(6) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purposes or the organizations that the court determines are organized and operated exclusively for charitable, educational, religious or scientific purposes.

(d) The names and addresses of the members are:

#### ARTICLE V OFFICERS

The affairs of this corporation shall be managed by officers elected by the board of directors at its organizational meeting. The officers shall serve until the next annual meeting of the board of directors, unless removed earlier in accordance with the bylaws.

#### ARTICLE VI DIRECTORS

This corporation shall have a board of directors of three (3) directors initially, which will serve as the general managers. The number of directors shall be prescribed in the bylaws from time to time. The names and addresses of the directors who shall serve until the first election are:


