ARTICLES OF INCORPORATION OF

E.R. REWIS WATER & SPIRIT OUTREACH, INC. a Florida not-for-profit corporation

<u>ARTICLE I</u> <u>Name</u>

The complete legal name of the Corporation is:

E.R. REWIS WATER & SPIRIT OUTREACH, INC.

ARTICLE II Duration

The term of existence of the Corporation is perpetual. The corporate existence will commence upon filing of these Articles by the Department of State.

ARTICLE III Purpose

The Corporation is a non-profit public benefit corporation and is not organized for the private gain of any person, and is for the support of public worship, the building and maintenance of churches, parsonages, schools, hospitals, chapels, and other religious, educational, or benevolent institutions as may be necessary or proper for the work of the missionary bodies in the United States or in any foreign country, and the maintenance of all missionary undertakings.

ARTICLE IV Directors

ARTICLE V Registered Office and Agent

ARTICLE VI Directors

The Corporation shall have three (3) Directors. The qualifications for Directors and the manner of their admission are to be regulated as set forth in the By-Laws of the Corporation.

ARTICLE VII Special Provision

- A. This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- B. Notwithstanding any provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code, or (b) by corporation contributions which are deductible under Section 170(c)(2) of the Internal Revenue Code.
