ARTICLES III Purpose(s)

The specific purpose(s) for which the corporation is organized are: To target girls and woman minorities, all which are in low income families. Phase stands for: Present Help for Adolescents and Adults Shaping the future economy.

Phase One of the program will target girls the ages of 9 through 18. Grades 3 through 12. The purpose of this portion of the program is to target girls of low income and minority families. To encourage the furtherance of education and pregnancy prevention. The program will work with the schools in the community in which it is set up and assist these girls with their needs, and encourage those girls who have a strong academic background to pursue college degrees. And those that do not, to have vocational training. The program will assist them scholarships, financial aids to continue their education. The program directors, coordination, counselors, and volunteers will work closely with the schools and other community organizations who have the same goals in mind for these girls. The girls will have teams set up by their peers and will provide support for each other as well.

Phase Two: This phase of the program will work with yours girls and their off-spring. Phase Three: This is the final stage of the program. It is established for singles-minority parents, who makes less than 30,000 a year. This portion of the program will assist women the ages of 19 through 45 to re-enter the college/vocational setting. This phase of the program will offer both financial and emotional support to these single parents and their children. By: acknowledging that when the proper opportunities are given a person can reach their highest potential, all they will need is an open door that will lead to success.

ARTICLES IV Manner of Election of Directors
