## ARTICLES OF AMENDMENT To ARTICLES OF INCORPORATION Of Phase Three Program, Inc.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

## ARTICLE 111 PURPOSE(S)

The specific purpose(s) for which the corporation is organized exclusively form charitable, educational, religious, or scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue code (or corresponding section of any future Federal tax code).

To target girls and women minorities, all which are in low income families. The word PHASE stands for Present Help for Adolescents and Adults Shaping the Future Economy.

Phase One of the program will target girls the ages of 9 through 18. Grades 3 through 12. The purpose of this portion of the program is to target girls of low income and minority families. To encourage the furtherance of education and pregnancy prevention, the program will work with the schools in the community in which it is setup to do the following tasks: assist these girls with their needs, encourage those girls who have a strong academic background, to pursue college degrees and those that do not, to have vocational training. The program will assist them with scholarships and financial aids to continue their education. The program directors, coordinators, counselors, and volunteers will work closely with the schools and other community organizations that have the same goals in mind for these girls. The girls will have teams setup by their peers and will provide support for each other as well.

Phase Two: This phase of the program will work young girls and their offspring. The program will encourage these girls and young women to continue their education and provide assistance to help them do so. They will receive services which will include: housing assistance, childcare assistance, job assistance, gas allowance, clothing and personal care allowance, and counseling services when needed. But the most important factor of all is, they will be encouraged to succeed and meet their educational goals.

Phase Two: This is the final of the program. It is established for single parents who are female and a minority who make less than 30,000 a year. This portion of the program will offer both financial and emotional support. These will be between the ages of 19 and 45. These will be encouraged to re-enter the college/vocational setting. This

phase of the program will offer the same benefits as phase two portion of the program but will also provide assistance to their children. The most important factor is, acknowledging that when the proper door opens, it will lead to opportunities, in which a person can reach their highest potential and be a success.
