### ARTICLE I: NAME

The name of this corporation shall be CHRIS STOKES MINISTRIES, INC.

### ARTICLE II: PRINCIPAL OFFICE

The principal place of business will be 120 Powell Boulevard, Apt. 6202, Daytona Beach FL 32114.

### ARTICLE III: PURPOSE(S)

1. The specific purpose (s) for which the corporation is organized is to:
  - A. Provide a Non-Profit Organization which will support and augment the Youth groups and Musical Programs at various churches.
  - B. The Organization is organized exclusively for, and will be operated exclusively for one or more reasons of Charity or Religious assistance to Youth and Musical Programs.
