ARTICLES III

Purpose(s)

The specific purpose(s) for which the corporation is organized is to reach a lost and dying world. To meet the needs of all people by feeding the hungry both here in the United States and in other countries. To administer clothing to the needy. To provide health care services here and in other countries. To reach all groups of people regardless of race, color, or national origin. To reach those in jail or prison. To train in ministry and provide quality Christian education to people of all ages. To carry the gospel to many cities in order to reach the lost. To establish ministries here in the United States and in other countries.

This said corporation is organized exclusively for one or more of the purposes as specified in Section 501C3 of the Internal Revenue Code including, for charitable, educational, and religious purposes. The making distributions to organizations that qualify as exempt organization that qualify as exempt organizations under Section 501C3 of the Internal Revenue Code, or corresponding section of any future federal tax codes.

However, if the named recipient is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this corporation/organizations shall be distributed to a fund, foundation, or corporation organized and operated exclusively for the purposes specified in Section 501C3 of the Internal Revenue Code or corresponding Section of any future Federal tax code.

No substantial part of the activities of this corporation shall consist of carrying on proper gander, or other wise attempting to influence legislation (except as otherwise provided by section 501(H) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements, or any political campaign on behalf of, or in opposition of any candidate for public office).

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to it's members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation shall be authorized and empowered to pay reasonable compensation for services rendered and to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.
