



During the process of filing the 2002 Uniform Business Report, the Cooper City Softball Booster Club, Inc. learned that there was a problem with their 2001 filing. They discovered that the 2001 form did not list each officer as also a director. Apparently you had sent them a notice regarding this, which they did not receive. The mailing address on file was that of a former officer, who will not forward any mail and is extremely uncooperative. She refuses to turn over any records to the Club.
