ARTICLES OF INCORPORATION OF  
LIVING WORD COMMUNITY BAPTIST CHURCH, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be LIVING WORD COMMUNITY BAPTIST CHURCH, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 500 56<sup>th</sup> Avenue South, St. Petersburg FL 33705:

ARTICLE III: PURPOSE(S)

The specific purposes for which the corporation is organized is the operation of a Baptist church and engage in any activity reasonably related thereto.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS
