**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
MARBELLA PHASE I OWNERS' ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned, Sham Maharaj, Secretary and President of Marbella Phase I Owners' Association, Inc. (the "Corporation"), for and on behalf of the Corporation, hereby adopts the following amendment to its Articles of Incorporation:

**FIRST:** The name of the Corporation is Marbella Phase I Owners' Association, Inc., whose document number is N99000000508.

**SECOND:** Article I of the Articles of Incorporation is hereby deleted and replaced with the following:

**ARTICLE I**

**NAME OF CORPORATION**

The name of the Corporation is Midtown Phase I Owners' Association, Inc., (hereinafter called the "Phase I Association").

**THIRD:** Article II of the Articles of Incorporation is hereby deleted and replaced with the following:


**ARTICLE II**
