WE, THE UNDERSIGNED INCORPORATORS, by these Articles of Incorporation hereby form a Not-For-Profit Corporation pursuant to the provisions of Chapter 617 of the Florida Statutes.

Article I

The name of this Not-For-Profit Corporation shall be:

The principal place of operations of this corporation and the mailing address of the corporation shall be 9264 Rutledge Avenue, Boca Raton, FL 33434.

Article II

This corporation is organized exclusively for charitable, religious, educational, and literary purposes with in the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 with a corresponding provisions of any future United States Internal Revenue law.
