**ARTICLE I**

The name of the corporation shall be Somo Ka, Inc.

**ARTICLE II**

The principal office of the corporation shall be 21916 Old Providence Rd. Alachua, Fl. 32615. The mailing address of the corporation shall be P.O. Box 1387, Alachua, Fl. 32616.

**ARTICLE III**

Somo Ka, Inc., is a not-for-profit educational, literary, scientific, research, and charitable service organization whose sole purpose is to help people live healthier and therefore more fulfilling and productive lives within the understanding of section 501 (c) (3) of the Internal Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

Somo Ka, Inc., fulfills this mission through providing and sponsoring educational seminars, workshops, classes, forums, gatherings, programs, travels, and services to the general public in the evolving field of consciousness studies, health, and healing, known as Energy Medicine.

**ARTICLE IV**
