**ARTICLES OF INCORPORATION**

The undersigned incorporation, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following articles of incorporation:

**ARTICLE I NAME**

The name of the corporation shall be:

ABAN MINISTRIES, INC.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation shall be

Post Office Box 2364, Brandon, FL 33509-2364

**ARTICLE III PURPOSE(S)**

The specific purpose(s) for which the corporation is organized is(are):

**SECTION 1** - The purpose of the corporation shall be for the sole purpose of spreading the Gospel of Jesus Christ in Seminars and Crusades throughout the Nation and abroad.

**SECTION 2** - The corporation will operate a television ministry with designated funds received in its campaigns. The television ministry will be strictly for Christian teaching outreach.

**SECTION 3** - The corporation will operate a Radio Broadcast Ministry with designated funds received from its campaigns. The Radio broadcast ministry will be for Christian teaching and increasing membership of the church.

**ARTICLE IV MANNER OF ELECTION OF DIRECTORS**

The manner in which the directors are elected or appointed is:

**SECTION 1** - They shall be elected as provided by the by-laws. The number of the Board of Trustees may be increased from time to time by the By-laws, but shall never be less than three (3).

**SECTION 2** - They must be born-again of the Spirit of God, according to ST. John Chapter 3, and in good moral standing with their local church affiliation.

**SECTION 3** - They shall attend to all legal business in connection with the activities of the corporation.

**SECTION 4** - They shall hold the same office (one in the same as the Board of Directors).
