ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **MISSIONARY COMMUNICATIONS, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 1011 Bill Beck Blvd., Kissimmee, FL 34744.

ARTICLE III: PURPOSE

The specific nature of business is to facilitate communications between missionaries and the churches, individuals and mission supporters in the United States.

ARTICLE IV: QUALIFICATION
