ARTICLES OF INCORPORATION OF THE SAFE HOME FOUNDATION INC.

OWSON CHEST STATIONS

ARTICLE I

The name of the corporation shall be The Safe Home Foundation Inc.

ARTICLE II

The principal place of business and mailing address of The Safe Home Foundation Inc. shall be 1821 Hiltonia Circle West Palm Beach Florida 33407.

ARTICLE III

The purposes for which The Safe Home Foundation Inc. is formed are:

- (a) to develop, promote, finance, build and manage the creation of housing and care for the elderly, the poor and those dealing with illness (i.e. AIDS, substance abuse).

- (d) Not withstanding any other provisions of this Certificate, the corporation shall not carry on any other activities not to be carried on by a corporation exempt from the Federal Income Tax under Section 501©(3) of the Internal Revenue Code of 1954(or under a corresponding provision of any future United States Internal Revenue Law).

ARTICLE IV

The Safe Home Corporation Foundation Inc. duration shall be perpetual and the corporation shall have no members and no stock.

Directors shall be elected as stated in the by-laws.
