in Broward County. The corporation is organized pursuant to the

The corporation is organized under the Non-profit Public Benefit Corporation Laws for Religious purposes. In accordance with the Doctrine of the corporation creed/by-laws as a minister to spread the gospel of Jesus Christ. The religious program will consist of Economic Development Programs, but, shall not be limited to: Homelessness, Health Care, Child Care, Youth At High Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
