ARTICLES OF INCORPORATION

OF

CITRUS COUNTY YOUNG MARINES, INCORPORATED

The undersigned, acting as incorporators of a corporation (hereinafter referred to as the "corporation") under provisions of Chapter 617, Florida Statutes, as amended from time to time, adopt the following Articles of Incorporation:

ARTICLE I. The name of the corporation is CITRUS COUNTY YOUNG MARINES, INCORPORATED.

ARTICLE II. The purpose for which this corporation is organized is to provide a youth organization drug reduction program for youths from age eight to eighteen.

ARTICLE III. This corporation is to have perpetual existence and the effective date upon which this Corporation shall come into existence shall be as soon as the Articles are filed with the Secretary of State.

ARTICLE IV. The initial post office address of the principal office of this corporation in the State of Florida is: 9156 S. Zanmar Drive, Floral City, Florida, Florida 34436. The street address of the corporation is the same.

of the corporation at the first corporate meeting of each calendar year which shall be held within the first thirty (30) days of said calendar year.

ARTICLE VI. The qualifications of the members of the corporation and the manner of their admission shall be governed by the Board of Directors.

amended by a majority vote of the members of the corporation and the filing of the appropriate instruments with the Secretary of State, State of Florida, and any proposals to amend said Articles may be made by any member of the corporation.

ARTICLE X. The Registered Office of the corporation is 9156 S. Zanmar Drive, Floral City, Florida 34436 and the Registered Agent of the Corporation at the same address is RICHARD A. YOUNG.

ARTICLE XI. The Corporation is organized exclusively for the benefit of providing a non profit organization for youths from age eight to eighteen.

article XII. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set

forth in Article XI hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempted from the Internal Revenue Code of 1954 or (b) by a corporation, contributions to which are deductible under Section 170(c)2 of the Internal Revenue Code of 1954, or the corresponding provision of any future amended United States Internal Revenue Code.

ARTICLE XIII. Upon the dissolution of this corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)3 of the Internal Revenue Code of 1954, as the Board of Directors shall determine. Any such assets not so disposed of shall be

disposed of by the Circuit Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or such organization or brganizations the Court shall determine, as brganized and operated exclusively for such purposes.
