
I previously submitted by courier the Corporation Reinstatement Form (and copy) for Fire To The Nations Inc., along with a check for the reinstatement of \$542.50 and a note requesting that the filing date be effective December 26th or December 31, 2012 (date UPS package delivered to your office).

As I checked on online I noticed that the reinstatement still had not yet been filed, so I called your office today and was told that even though the courier package was received at your courier address, your office is treating the package as delivered on a later date since it was not delivered by your internal mail department to the reinstatement department until the new year. As a result, the package as returned to the Fire To The Nations mailing address, defeating the purpose of sending the package to you by UPS.
