WE, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a not for profit (non-profit) corporation under Florida Statute, Chapter 617, and other applicable provisions of the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be AFRICAN UNITED ASSOCIATION OF MIAMI, INC. . and the initial address of the corporation shall be Courthouse Plaza, 28 W. Flagler Street, Suite 510, Miami, Florida 33130-1890.

ARTICLE II

This corporation is formed for the primary purpose of (a) forming a social soccer club, and (b) any business voted by the Board of Directors and permitted under the law of the state of Florida for a non-profit corporation of this nature.

ARTICLE III

The membership shall be open to anyone with an interest in soccer, who applies to the Board and pays his membership dues.

ARTICLE IV

This corporation shall commence its existence effective as of February 1, 1999, and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE XI





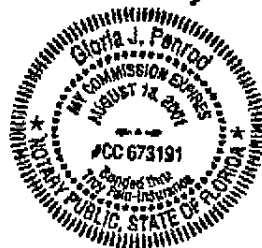
