**ARTICLES OF AMENDMENT,
SPRINGS RIVER FESTIVAL, INC.**

(A Florida Nonprofit Corporation)

Pursuant to Florida Statutes Section 617.1002(1)(b), the Articles of Incorporation of the above named Corporation are hereby amended as follows:

1. Article II, PURPOSE, is hereby amended to include the following provision:

Notwithstanding any other provision of these Articles, said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

2. There are no members entitled to vote on this amendment.
3. The foregoing amendment to the Articles of Incorporation filed February 1, 1999, was adopted at a meeting of the board of directors held February 11, 2000, by a majority vote of the directors then in office.

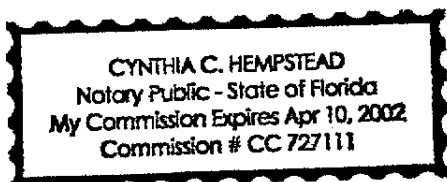


