ARTICLES OF INCORPORATION

OF

BREVARD CITIZENS AGAINST POLLUTION, INC.

A NON-PROFIT CORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be Brevard Citizens Against Pollution, Inc. (BCAP)

ARTICLE II

ARTICLE III

The specific purpose for which this corporation is organized is to educate the public, local government, other concerned citizens and environmental groups to the sources of pollution and their effect on our quality of life.
