ARTICLES OF INCORPORATION

OF MOTHER'S ANGELS, INC.

ARTICLE I - NAME

The name of the corporation is MOTHER'S ANGELS, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS The place where the corporation's principal office is to be located is 72 N.E. 5 Avenue Delray Beach, Fl 33483.

ARTICLE III - PURPOSE

The purpose for which the corporation is formed is to engage in any lawful act or activity for which corporations may be formed under Chapter 496,F.S., including the operation of a non-profit children's day care center.

This corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal revenue Code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV - BOARD OF DIRECTORS

This corporation shall have three directors who will be elected at the annual meeting.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
