BY THESE ARTICLES the incorporator forms a corporation under the Florida Not For Profit Corporation Act.

1. NAME. The name of this corporation is GOOD BRIDGE 2000, INC.
2. PRINCIPAL OFFICE. The address of the principal office of this corporation is 1740 Wisconsin Lane, Sarasota, Florida 34239 and its mailing address is P.O. Box 4019, Sarasota, Florida 34230.
3. PURPOSE. The purpose for which this corporation is organized is to obtain the replacement of the present drawbridge on the Ringling Causeway in Sarasota, Florida by a high bridge that does not require a draw span; to appear before any public body in connection with this project; to publish and distribute materials concerning the project; to use all methods of communication to persuade governmental authorities having jurisdiction to replace the present drawbridge with a high fixed bridge and to take any other action necessary or desirable to implement this purpose.
4. DIRECTORS. The method of selecting directors of this corporation shall be stated in the bylaws. This corporation shall have six directors initially. 


