

- TWO** This corporation is a nonprofit mutual benefit corporation. The corporation is organized under the Nonprofit Mutual Benefit Profit Corporation Law for real estate, real estate transactions, and mortgage brokerage purposes.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.


