The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby certifies the following for the purpose of forming a not-for-profit corporation under the laws of the State of Florida, pursuant to Chapter 617 et. seq., Florida Statutes.

ARTICLE I. NAME

The name of the corporation shall be:

The principal place of business of this corporation shall be: 9307 SE Olympus St., Hobe Sound, FL 33455

ARTICLE II. NATURE OF BUSINESS

The purpose for which the corporation is organized is to publish a controlled circulation newspaper for residents of Martin County, Florida.

ARTICLE III. MEMBERS

The members of this corporation shall consist of individuals or persons who are interested in the purposes and objects of the corporation, who have been elected to membership and have made a contribution to the corporation, all in accordance with the bylaws of the corporation.

ARTICLE IV. REGISTERED AGENT:

The corporation has named BERNHARD M. AUER, 37 North Beach Road, Hobe Sound, FL 33455, to serve as its resident agent to

accept service of process.

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually, but shall be subject to dissolution under Fla. Statutes 617.1402 or any other applicable state law.

The By-laws of the corporation shall initially be made and adopted by its first Board of Directors. The By-laws may be amended, altered, supplemented or modified in accordance with the relevant provisions concerning amendment, alteration, supplementation or modification as may be contained in said Bylaws.

ARTICLE XI: AMENDMENTS

The corporation shall have all the powers set forth in Section 617.0302, Florida Statutes.

ARTICLE XIII: DIVIDENDS, COMPENSATION AND STOCK

There shall be no dividends paid to any of the members, nor shall any part of the funds collected by the corporation be distributed to its Board of Directors or Officers. The corporation may pay compensation in a reasonable amount to its members, directors or officers for services rendered, may confer benefits upon its members in conformity with its purposes, and upon dissolution or final liquidation, may make distribution to its members as is permitted by the Court having jurisdiction thereof, and no such payment, benefit or distribution shall be deemed to be a dividend or distribution of income.

ARTICLE XIV: INDEMNIFICATION

Every director and every officer of this corporation shall
be indemnified by the corporation against all expenses and
liabilities, including counsel fees, reasonably incurred by or
imposed upon him in connection with any proceedings to which he
may be a party, or in which he may become involved, by reason of
his being or having been a director or officer of this
corporation, or any settlement thereof whether or not he is a
director or officer at the time such expenses are incurred,
except in cases where the director or officer is adjudged guilty
of gross negligence or willful misconduct in the performance of
his duty. The foregoing right of indemnification shall be in
addition to and not exclusive of all other rights to which such
director or officer may be entitled.

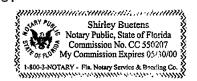

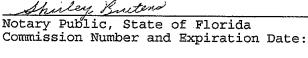

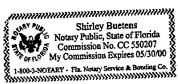
