

ARTICLES OF INCORPORATION OF THE PLINTON GROUP, INC.

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not-for-Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME

The name of this corporation shall be the Plinton Group, Inc., hereby referred to as Corporation.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address of the corporation is:

ARTICLE III. PURPOSE
