NAME

ARTICLE II
PURPOSE

The purpose for which the corporation called CORA LEE PALMER MINISTRIES, INC., is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE VII
QUALIFICATION OF MEMBERS

Members shall be freely admitted to the Corporation, who are willing to promote the purpose of this corporation. The qualification of members shall be set by the by-laws of the corporation. Men, Women, Boys and Girls will be freely accepted to the membership.

ARTICLE VIII
MANAGEMENT

The daily affairs of the Corporation are to be managed by the Minister, who serves on a permanent basis, or a person designated by her to assist in the management of the corporation.

The property of this corporation is irrevocably dedicated to the charitable purpose and no part of the net income or assets of this organization shall ever inure to the benefits of any private person. Upon dissolution of the organization assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) if the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the Federal, State or local government for public purposes. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for which purposes.


