

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

Any assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal Office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said (cont.)


