**ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

**ARTICLE I Name**

The name of the corporation shall be the Home Improvement Research Institute, Inc.

**ARTICLE II Offices**

The Institute's principle place of business and mailing address shall be:  
Home Improvement Research Institute, c/o Lebar-Friedman, Inc., 3922 Coconut Palm Drive, Suite 300, Tampa, Florida 33619

**ARTICLE III Purpose(s)**

The specific purpose(s) for which the corporation is organized are:

1. To gather data and initiate research concerning the home improvement industry, with a specialization on consumer and professional remodeler activities, and to disseminate the results to the Members of the Institute and to the following other segments when deemed appropriate:
  - A. Consumer / Professional Public
  - B. Home Improvement Industry in General
2. To engage in other lawful and appropriate activities to further the conditions and growth of the home improvement industry and the Institute itself.

**ARTICLE IV Manner of Election of Directors**

The Board of Directors are elected by the Member Council. The Board of Directors shall consist of 18 members elected from the Member Council. The Board of Directors shall be chosen to represent all segments of the membership; although no quotas will be set due to the changing nature of the membership.
