## ARTICLES OF INCORPORATION

EFFECTIVE DATE  
2-1-99

The undersigned incorporator, a majority of whom are citizens of the United States, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, and Section 501 ©(3) of the Internal Revenue Code, hereby adopts the following Articles of Incorporation:

### ARTICLE I NAME

The name of the Corporation shall be: **JOEL'S PLACE, INC.**

### ARTICLE II PRINCIPAL OFFICE

The place in this state where the principal office of the Corporation is to be located is the City of Lantana, Palm Beach County.

### ARTICLE III PURPOSE

Said Corporation is organized exclusively for religious purposes, including, for such purposes, the making of distributions that qualify as exempt organizations under Section 501©(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, and said purpose of the Corporation is limited under Section 501©(3) of the Code.

### ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The directors are elected or appointed by the majority of the shareholders of the corporation.

ARTICLE VII EFFECTIVE DATE OF INCORPORATION

The effective date for said corporation shall be FEBRUARY 1, 1999

ARTICLE VIII DISTRIBUTION OF NET EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, shareholders, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

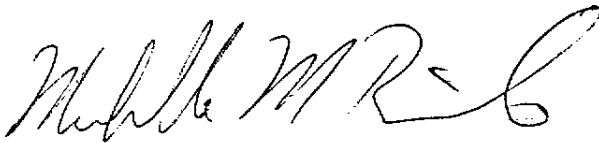
ARTICLE IX DISSOLUTION OF THE CORPORATION

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government.

ARTICLE X AMENDMENT

*This corporation reserves the right to amend or repeal any provision contained in these articles of incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.*
