

AMENDED ARTICLES OF INCORPORATION FOR

HOMEGIRLS, INC.

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

HOMEGIRLS, INC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

14410 79TH COURT NORTH LOXAHATCHEE, FL 33470

ARTICLE III PURPOSE

The specific purpose for which the corporation is organized is:

Homegirls is a spiritual support group that is dedicated to the spiritual growth of our families and the uplifting of each other via Christian Bible Study and other resources. We are committed to excellence in communicating Biblical truth and reflecting Biblical truth in our homes and in our communities. Homegirls also provides emotional support, cultivates high self-esteem, and nurtures life-long spiritual friendships among the members.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed are as follows:

The names and post office addresses of the members of the first Board of Directors and Officers who shall hold office for the first year of existence of the corporation or until their successors are elected or appointed is provided in the by laws.

ARTICLE V EXEMPTION CLAUSE

- A). Homegirls is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the shall be authorized and empowered organization reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on attempting otherwise or legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of propaganda, statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Code, Revenue Internal section 170(c)(2) of the corresponding section of any future federal tax code.
- C). Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VI LIMITATION OF CORPORATE POWERS

The corporation powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:
