The undersigned incorporator, for the purposes of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

Article I Name

The name of the corporation shall be Panama City Bowling Association, Inc.

Article II Principal Office

The principle place of business and mailing address of this corporation shall be:

Article III Purpose

The specific purposes for which the corporation is organized are the management of financial business for a local ABC sports organization which works with youth organizations; collects funds for charitable causes; provides scholarship funds for local students; participates in community service work; and recognizes outstanding achievements by participants in the sport.
