The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE ONE NAME AND PRINCIPAL PLACE OF BUSINESS

ARTICLE TWO DURATION OF CORPORATION

Perpetual, unless dissolved according to law.

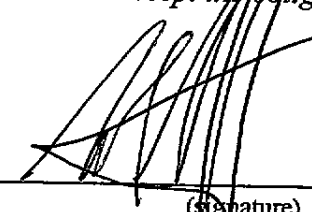
