ARTICLES OF INCORPORATION
of

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida as a corporation not for profit, and hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME JESUS OUR ONLY HOPE CHRISTIAN CHURCH, INC.

ARTICLE II-PLACE OF BUSINESS OF THE CORPORATION

5344 Red Bug Road, Casselberry, FL 32718

ARTICLE III- PURPOSE

The purpose for this church is religious, charitable and educational.

The members of this corporation shall be the members of the church.

ARTICLE IV - TERM OF EXISTENCE

The corporation shall have perpetual existence.

ARTICLE V - NAMES AND RESIDENCES OF THE INCORPORATORS

ARTICLE VI - BOARD OF DIRECTORS

Section 1. The number, term of office and provisions regarding removal and filling of vacancies shall be set forth in the corporation, Bylaws.

ARTICLE VII - AMENDMENTS

Amendments to this Articles of Incorporation shall be proposed by a resolution adopted by a majority vote of the board of trustees. The resolution shall then be presented to the membership of the corporation. A majority vote of the membership cast at a duly called meeting shall be necessary to amend the Articles of Incorporation.

ARTICLE VIII - VOTING

Section 1. Each member in good standing shall be entitled to one vote.

Section 2. Votes may be cast either in person, by proxy or by voting trustee or trustees, each of whom may, but not, be officer or director of the corporation.

ARTICLE IX - ADDITIONAL PROVISIONS

Section 1. No officer, director or member shall be personally liable for any debt or other obligation of the corporation.

Section 2. The corporation shall not be operated for profit. No dividend shall be paid, and no part of the income of the corporation shall be distributed to its members, directors, or officers.

Section 3. Where the context of these Articles permits, the use of the plural shall include the singular and the singular shall include the plural, and the use of any gender shall be deemed to include all genders.

ARTICLE X - SEVERABILITY

Should any paragraph, sentence, phrase, or portion thereof, of any provision of these Articles or of the Bylaws or rules and regulations be held invalid, it shall not affect the validity of the remaining parts thereof or of the remaining instruments.

**ARTICLE XI - APPOINTMENT OF REGISTERED AGENT
FOR SERVICE OF PROCESS**

Pastor Cesar Chin is appointed registered agent for service of process upon the corporation.

**ARTICLE XII - RESTRICTION ON USE OF CORPORATION
ASSETS AND EARNINGS**

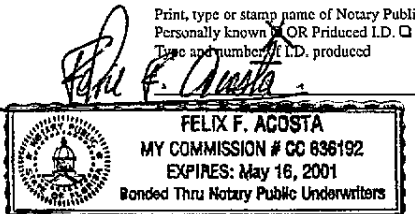
No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensations for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof, No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.


ARTICLE XIII - DISTRIBUTION OF ASSETS UPON DISSOLUTION


