ARTICLE OF INCORPORATION

OF

THE HOUSE OF GOD OF BREVARD COUNTY, INC. (A Non-profit Corporation)

ARTICLE I - NAME

The name of this corporation is THE HOUSE OF GOD OF BREVARD COUNTY, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of being a non-denomination church and to perform all acts including the conduct of worship services, customarily performed by a church, and for any other lawful purposes.

ARTICLE IV - NON - STOCK CORPORATION

This non-profit corporation shall be non-stock, and no dividends or pecuniary profits shall be declared or paid to the members thereof. This is a 501(c)(3) corporation as provided by the Internal Revenue Code of 1986.

ARTICLE V - POWERS

In furtherance of the objectives described above, but not in limitation thereof, the non-profit corporation shall have power insofaras power is conferred, or is not limited by law, to make and perform contracts for any lawful purpose and to engage in various funding and fund-raising activities and for all other lawful purposes provided for non-profit corporations.

ARTICLE VI - MEMBERSHIP

The non-profit corporation membership shall consist of all of the present members in good standing and such other members as may be added to it by the church through its present members in accordance with usages, customs and traditions of the church, and as provided by its By-laws.

ARTICLE VII - ADDRESS OF PRINCIPLE OFFICE

The initial post office address of the principle office of this corporation shall be Post Office Box 361032, Melbourne, Florida, 32941.

ARTICLE VIII - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 2125 Bridle Path, Melbourne, Florida, 32935, and the name of the initial registered agent of this corporation at that address is REV. WILLIAM R. ROSE.

ARTICLE IX - INITIAL BOARD OF DIRECTORS

This non-profit corporation shall have three directors initially. The number of Directors may be increased at any time by the By-laws, but shall never be less than three. The qualifications, the time and manner of electing, the terms and duties of office, and the manner of filling vacancies shall be set forth in the By-laws. The names of the initial Directors of this non-profit corporation are as follows:

ARTICLE XI - OFFICERS

Elective Officers: The officers of this non-profit corporation shall be determined by the By-laws, but shall never be less than one. The qualifications of, the time and manner of electing, the duties of, the terms of office, and the manner of removing officers shall be set forth in the By-laws. The qualifications of, the time and manner of electing, the duties of, the terms of office, and the manner of removing officers shall be set forth in the By-laws.

ARTICLE XII - FISCAL YEAR

The fiscal year of this non-profit corporation shall be from January 1 to December 31.

ARTICLE XIII - AMENDMENT TO ARTICLES

These articles may be amended or repealed, in whole or in part, only by a majority vote of the non-profit corporation members present at any duly organized meeting of the corporation called for that purpose.

ARTICLE XIV - BY-LAWS

The initial By-laws of this non-profit corporation shall be adopted by the members. Such Bylaws may be amended or repealed, in whole or in part, in the manner provided therein, and the amendments to the By-laws shall be binding on all its members, including those who may have voted against them.

ARTICLE XV - MEETINGS OF THE MEMBERS

The first annual meeting of the members shall be held within ninety (90) days of the creation of this non-profit corporation at a place and time to be determined by the Board of Directors.

ARTICLE XVI - QUORUM AND MAJORITY

At all meetings of the Board of Directors of this non-profit corporation, and at all meetings of the members of this non-profit corporation, a quorum for such meeting shall be held as provided in the By-laws.

ARTICLE XVII - DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in section 501(c)(3) and 170 (c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the federal, state or local government for exclusive public purpose.
