# Articles of Ammendment For United Christian Outreach Ministries, Inc.,

## Article of Ammendment 1

In the event of dissolution the residual assets of the organization will be turned over to one ore more organization(s) which themselves are exempt as organizations described in the Sections 501(C) (3) and 170(C) (2) of the Internal Revenue code of 1954 or any corresponding sections of any prior or future law or the Federal, State or local government for exclusive public purpose.

## Article of Ammendment II

Notwithstanding any other provision of these articles this corporation will not carry on any other activities not permitted to be carried on

- (a) by a corporation exempt from Federal Income Tax under Section 501(C) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law or
- (b) by a corporation, contributions to which are deductible under Section 170(C) (2) of the Internal Revenue Code of 1994 or any other corresponding provision of any future United States Internal Revenue Law.

## Article of Ammendment III

Said corporation is organized exclusively for charitable, religious, educational and scientfic purposes. Including such purpose as, the making of distributions to organizations that qualify as exempt organizations under Section 501(C) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).


Article of Ammendment IV
