ARTICLES OF INCORPORATION OF  
VESSELS OF HONOR MINISTRIES, INC.

The undersigned, for the purpose of forming a corporation not for profit under the Florida Not For Profit Corporation Act, adopt the following Articles of Incorporation for the corporation:

ARTICLE ONE  
NAME

The name of the corporation is Vessels of Honor Ministries, Inc. This corporation's outreach ministries include but are not limited to Teen M.O.M. (mothers of miracles) and Sisters-in-Service. Teen M.O.M. mentors single teen girls who are pregnant or are already mothers. Sisters-in-Service encourages women of all demoninations to become involved in community service projects.

ARTICLE TWO  
PRINCIPAL OFFICE

The street and mailing address of the initial principal office of the corporation is 2309 Forsythe Ct., Tallahassee, FL 32308.

ARTICLE THREE  
CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE FOUR  
PURPOSES

The corporation is a not for profit corporation. The corporation is organized for religious purposes, specifically a non-demoninational ministry intended to reach women and girls of all ages so that they may know and experience Jesus Christ.

The corporation is to operate exclusively for religious purposes as described above which will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for those purposes, the making of distributions to organizations which qualify as tax exempt organizations under that Code.

This corporation shall not carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or

otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE FIVE  
REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 106 East College Street, Suite 900, Tallahassee, Florida, 32301, and the name of its initial registered agent at such address, is Ricky Polston, Polston & Dean, P.A.

ARTICLE SEVEN  
DIRECTORS

The powers of this corporation shall be exercised, its property controlled, and its affairs conducted by a board of directors. There shall be three directors of the corporation, initially the incorporators as stated above.


ARTICLE EIGHT  
PROPERTY

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member, or to the benefit of any private individual. This provision does not prohibit, however, the Pastor and other staff of the corporation from receiving a reasonable compensation for their services to the corporation.

On the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and which

has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.






