The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act and the Florida not for Profit Corporation Act, adopt the following articles of incorporation for such Corporation:

- Article I: The name of the corporation is APOSTOLIC LIFE CENTER INC.
- Article II: The principal place of business (renting)
Mailing address of this corporation shall be:

- Article III: The purpose is to establish and maintain a place of public worship; to own, hold intrust, use, or otherwise possess, sell, convey, mortgage, lease, or otherwise dispose of such property, real or chattel, as many be needed for the prosecution of its work; to establish such department as may be necessary for the ministering of the Gospel and the support of Missionary activities at home and abroad; and to conduct services as are in harmony with the Bible for the Edification, Evangelization, Commemoration, and confirmation of those for whom Jesus died.
- Article IV: The manner in which the directors are elected or appointed is:


