ARTICLES OF INCORPORATION

OF

FAMILY WORSHIP CENTER OF BROWARD INC.

CENTRO DE ADORACION FAMILIAR DE BROWARD INC.

We, the undersigned incorporators, each a natural person competent to contract, hereby associate ourselves together to form and establish a corporation NOT FOR PROFIT under the laws of the State of Florida.

FIRST:

The name of the corporation is FAMILY WORSHIP CENTER OF BROWARD, INC.

SECOND:

The location of its principal of business in the State is 6231 Buchanan st. Hollywood, Florida 33024.

THIRD:

The location of its registered agent in this State is 6231 Buchanan st. Hollywood, Florida 33024. The name of the registered agent of this corporation is HIPOLITO PAUL CRUZ.

FOURTH:

This corporation is organized NOT FOR PROFIT and the object and purposes to be transacted and carried on are; To preach the word of God, and to conduct its business in all its branches in the State of Florida or any other State, or territory in the United State of America and in all foreign countries, and bring forth the works that Jesus did by teaching, and feeding the needed and to aid in any and all forms possible to this corporation.

FIFTH:

The members of the corporation shall be those persons of good moral character and deportment whose applicatins are approved by a board of admissions.

SIXTH:

The private property of the members of this corporation shall not be liable for its corporation debts.

The director's of Family Worship Center of Broward Inc. shall be appointed by the board of advisors and voted on by the general assembly all in active membership, and by a 2/3 vote.

SEVENTH:

In the event of the dissolution of this corporation or in the event it shall cease to carry out the objects and purposed herein set forth, all the business property, and assets of the corporation shall go and be distributed to such non profitable and charitable corporation, municipal corporation or corporations as may be selected by the board of Directors of this corporation so that the business property and assets of this corporation shall in that event be used for, and devoted to, the purposes of carrying on another christian organization, and in no event shall any of said assets or property in the event of dissolution thereof, go or be distributed to members either for reimbursement of any sum subscribed, donated, or contributed by such members or for any other such purpose, it being the intent that in the event of the dissolution of this corporation, or upon ceasing to carry out the objects and purposes herein set forth the property and assets there owned by the corporation shall be donated to the carrying on the function and purposes of another christian organization as the board of directors shall determine and direct.

EIGHTH:

The affairs of the corporation are to be managed by a board of directors in elections to be held every four years.

NINTH:

The general officers of the corporation shall be a president, vice-president, a secretary, and a treasurer, one person can hold more than one office.

TENTH:

Amendments to the articles of incorporation may be proposed by any director of the corporation and adopted by (2/3) vote of the directors present at a regular meeting.

ELEVENTH:

The number of directors constituting the initial board of directors of the corporation is three and the name and addresses of the persons who are to serve as the initial directors are:

The above named persons will be the officers who are to serve until the first election or appointment under the articles of this corporation, and they are also the initial incorporators. The by-laws of the corporation are to be prepared by the initial board of directors and approved by a majority of the members in good standing in a meeting specially held for the purpose.

TWLFTH:

The by-laws of the corporation are to be made, altered or rescinded by amahority vote of the board of directors.

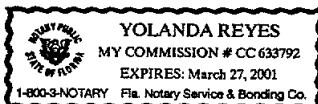

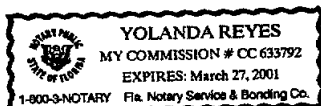
