## ARTICLES OF INCORPORATION

GREATER JACKSONVILLE YOUTH ATHLETIC COUNCIL, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

# ARTICLE I: NAME

The name of the corporation shall be: Greater Jacksonville Youth Athletic Council, Inc.
