**ARTICLE I - NAME**

The name of this corporation is Eagles Women's Intercessory Network, INC.

**ARTICLE II - DURATION**

This corporation shall have a perpetual existence commencing on February 20, 1999.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of organizing and promoting inter-denominational prayer and Christian fellowship and for transacting any or all-lawful business as allowed under the laws of the State of Florida.

**ARTICLE IV - NOT-FOR-PROFIT**

This corporation is a Florida not-for-profit corporation organized to comply with the terms and conditions of 26 U.S.C. section 501 as a not-for-profit corporation and compile all terms, rules and obligations thereof.

**ARTICLE V - INITIAL PRINCIPAL OFFICE**

The street address and mailing address of the initial principal office of this corporation is, 107 Lake Court, Niceville, Florida 32578.

**ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT**

**ARTICLE VII - INITIAL BOARD OF DIRECTORS**

This corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by the by-laws but shall never be less than one. The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.


### ARTICLE X - ACTION BY DIRECTORS WITHOUT A MEETING
