ARTICLES OF INCORPORATION

Article I

The name of the corporation shall be **Just B-CAUSE, Inc.**

The principle place of business of this corporation shall be P.O.Box 41333, St. Petersburg, Florida 33743-1333.

Article II

The period of the duration of this corporation is PERPETUAL unless dissolved according to law.

Article III

The purpose (purposes) for which the corporation are as follows:

- A. To operate exclusively for charitable, educational, and scientific purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law), and more specifically;
- B. To conduct research related to gender related cancers.
- C. To promote a program of general education designed to increase public awareness in hopes of insuring early detection, hence raising survivorship, and a comprehensive understanding of preventive care for gender related cancers.
- D. To provide for such services that would benefit and improve the health and welfare of those subject to gender related cancers.
- E. To promote a program of general education designed to give those who have gender related cancers a better understanding of their condition and to offer such further assistance and encouragement as will enhance the welfare of those individuals and their families.
- F. To promote among physicians and other health professionals the free exchange of knowledge with respect to gender related cancers and to cooperate with physicians, health professionals, and other medical and paramedical associations to improve the standards of diagnosis, care, and treatment of those suffering from gender related cancers.
- G. To provide scholarship opportunities for women of all ages.

H. In general, to raise, disburse, and administer funds and to take other appropriate action in the foregoing purposes.

Article IV

The qualifications of Directors and the manner of their admission are: as SPECIFIED IN BY-LAWS.

Article V

The names and addresses of the Directors, founders of this organization, organized and self elected during a meeting held at 5401 West Kennedy Boulevard, Suite 1000, Tampa, Florida 33609

The number constituting the Board of Directors of the corporation will increase to no more than eleven (11) selected as specified in the By-Laws in Article 4 sections 1 to 12.

Article VI

This corporation is organized under a non-stock basis.

Article VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (C) (3) and 170 (C) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.

Article VIII

The corporation's affairs are to be managed by a President, Vice President, Treasurer, and Secretary and such other officers as may be provided in the By-Laws.

The initial officers of the corporation who shall serve until their successor have been qualified and elected by the Board of Directors at its annual meeting, or as specified in the By-Laws, are:

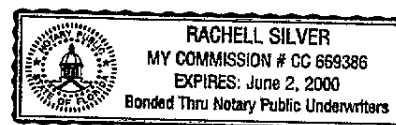
