ARTICLES OF INCORPORATION
FOR
MINISTERIO CRISTO VIENE YA, INC.

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The Name of the corporation shall be:

MINISTERIO CRISTO VIENE YA, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS:

The principal place of business and the mailing address of this corporation shall be:

1799 S.W. 8th Street, Miami, Florida 33135

ARTICLE III - PURPOSE

The specific purposes for which the corporation is organized are:

1- This Church is organized for the purpose of "Glorify God in the Salvation of Souls, the Edification of the Gospel of the Lord Jesus Christ, The promotion of Godly Worship, the defense of the Faith once delivered, and cooperation with Christian Activities functioning in harmony with God's Holy Word, Campaigns and other christian activities as to provide Food, Toys, Clothes to the poor people of the Greater Miami until Jesus Comes.

2- Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

This Church shall have a Board of Directors, consisting of at least three Directors, who shall be chosen by the members for a period of One Year.

ARTICLE V - LIMITATION OF CORPORATE POWERS

This Church shall be constituted by Faithful Christians (Born again), and the requirements to be a member of this Church shall be written on its Internal Regulations created for this purpose.

ARTICLE VI - INITIAL REGISTERED AGENT AND STREET ADDRESS

The name and the street address of the initial registered agent is:

ARTICLE VII - DISTRIBUTION OF ASSETS

Upon dissolution, liquidation and winding up of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation, in such manner, and to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes, as shall at the time qualify as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended, as the Board of Directors may determine. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for such purposes, or to such organization or organizations as such Court shall determine.
