ARTICLES OF INCORPORATION

We the undersigned, acting as Incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

A voluntary association and member of said church have voluntarily associated ourselves to form a non-profit corporation under the laws of the State of Florida, and we hereby certify that

ARTICLE I

The name of the corporation shall be: ROSE HILL MISSIONARY BAPTIST CHURCH, INC.

ARTICLE II

ARTICLE III

The specific purpose(s) for which the corporation is organized is (are):

To promote and encourage Religious Worship to provide for preaching of the Gospel, to circulate and teach the Bible, to carry on temperance, Missionary and Educational work, to minister to the sick and afflicted, and to lift up the fallen.

To construct, erect, and build other buildings necessary and incidental to said objects and purposes. It may buy, own, sell, lease, rent, all such property; real, personal and mixed as may be necessary to carry out the purposes of this corporation, and may acquire any such property by grant, gift, purchase, or bequest, and hold and dispose of such property as a corporation shall acquire for the benefit of the members.

To borrow money, contract debts, and issue bonds, notes, debentures and secure same to contract and to be contracted with.

ARTICLE IV

Limitation of Corporate Powers

The corporate powers of this corporation are as provided in section 167.302 of Florida Statutes, unless limited as follows:

The above enumerated objects and purposes shall not be construed as a limitation upon this corporation to carry out and perform any lawful activity. Authorized lawful activity by the membership may be necessary for the improvement of the church.

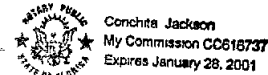
