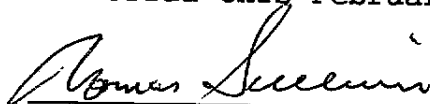
ARTICLE 9- AMENDMENT

Corporation intends to claim exemption from federal tax obligations as described in section 501 (c) 3 of the Internal Revenue Code.

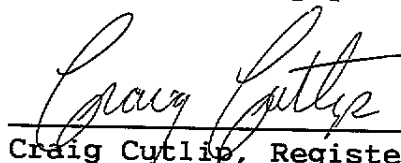
