ARTICLES OF INCORPORATION  
OF  
THE CHRISTIAN LEADERSHIP CENTER OF TALLAHASSEE, INC.  
A Corporation Not for Profit

The undersigned, in order to form a not-for-profit corporation for the purposes hereinafter stated, under and pursuant to the laws of the State of Florida, hereby subscribe to these Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is: THE CHRISTIAN LEADERSHIP CENTER OF TALLAHASSEE, INC.

ARTICLE II. PURPOSE

This Corporation does not contemplate pecuniary gain or profit to the members thereof, and the purpose for which it is formed is exclusively for Christian religious education, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements)

any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

### ARTICLE III. TERM OF EXISTENCE

The corporation is to commence its existence on the date and at the time of filing these Articles of Incorporation with the Secretary of State, State of Florida, and shall exist perpetually thereafter until dissolved sooner according to law. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

### ARTICLE IV. MEMBERSHIP

The qualifications for members and the manner of admission are to be regulated by the bylaws of the Corporation. Directors are to be elected in the manner set forth in the bylaws.

## ARTICLE V. INITIAL STREET ADDRESS

The street address in this state of the initial registered office of the corporation is: 215 South Monroe Street, Suite 400, Tallahassee, Florida, 32301 and its initial registered agent is Ralph C. Datillio.

## ARTICLE VI. NUMBERS OF DIRECTORS

The Board of Directors shall consist of not fewer than three (3) nor more than twelve (12) directors, who need not be members of the Corporation. The number of directors may be changed by amendment of the Bylaws of the Corporation. The names and addresses of the initial directors of this corporation are as follows:
