

ARTICLE V111 – AMENDMENTS

Amendments to this Articles of Incorporation shall be proposed by a resolution adopted by majority vote of the board of trustees. The resolution shall then be presented to the membership of the corporation. A majority vote of the membership cast at a duty called meeting shall be necessary to amend the Articles of Incorporation.

ARTICLE 1X - VOTING

Section 1. Each member in good standing shall be entitled to one vote. Section 2. Votes may be cast either in person, by proxy or by voting trustee or trustees, each of whom may, but not, be officer or director of the corporation.

ARTICLE X- ADDITIONAL PROVISIONS

Section 1. No officer, director or member shall be personally liable for any debt or other obligation of the corporation.

Section 2. The corporation shall not be operated for profit. Not dividend shall be paid, and no part of income of the corporation shall be distributed to its members, directors, or officers.

Section 3. Where the context of these Articles, permits, the use of the plural shall include the singular and the singular shall include the plural, and the use of any gender shall deemed to include all genders.

ARTICLE X1 - SEVERABILITY

Should any paragraph, sentence, phrase, or portion theirof, of any provision of these Articles or Of the Bylaws or rules and regulations be held invalid, it shall not affect the validity of remaining parts thereof or of the remaining instruments.

ARTICLE X11 – APPOINTMENT OF REGISTERED AGENT FOR SERVICE OF PROCESS

Pastor Pedro Betancourt is appointed registered agent for service of process upon corporation.

ARTICLES X111 – RESTRICTION ON USE OF CORPORATION ASSETS AND EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensations for services rendered and to make payments and distributions of furtherance of the purposes set forth in Article 11 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Not withstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax code, or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE X1V - DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) Of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local government for a public purpose. In no event shall the assets of the corporation be distributed upon dissolution to the members of the corporation.
