# ARTICLES OF INCORPORATION OF YOUNG ISRAEL OF BAL HARBOUR INC. a Florida not for profit corporation

### ARTICLE I

The name of the corporation is Young Israel of Bal Harbour Inc.

## ARTICLE II PURPOSES

The purposes for which this corporation is organized are as follows:

- 1. (a) To establish and maintain a synagogue conducting traditional orthodox services in accordance with the Shulchan Oruch, with proper decorum and congregational singing, free of commercialism, and to which, with the exception of the High Holy days, no admission charge shall be made; which shall have services daily including Sabbath and Jewish holidays; be affiliated with National Council of Young Israel and be bound by its constitution; and have as its officers and delegates to the National Council of Young Israel only persons who are Sabbath observers and whose synagogue affiliation is exclusively orthodox.
  - (b) The corporation may operate a religious school and may have a youth activity program.
  - (c) The corporation shall foster and maintain a program of spiritual, educational, cultural, social and communal activity towards the advancement and perpetuation of traditional, Torah-true Judaism, and instill in its youth and members an understanding and appreciation of the high ethical and spiritual values of Judaism, demonstrating the compatibility of the ancient faith of Israel with good Americanism.
- (a) It shall be the purpose of this organization to conduct a synagogue in strict
  accordance with the Orthodox Halalchic interpretation of Judaism and in
  keeping with the rules of the Synagogue Committee of the National Council
  of Young Israel.

There shall be no commercialism in connection with the synagogue or its (i) services.

Strict decorum shall be observed at all services.

- (ii) Young Israel congregational singing wherever possible will be conducted at (iii) all services.
- To provide proper facilities for the dissemination of knowledge of Jewish faith, (b) history, literature and Jewish life and ideals.
- To participate in worthy movements and activities which would be of benefit to the (c) . Jewish people, and to awaken them to their duties and responsibilities as Jews.
- To conduct educational and social activities in connection with the celebration of (d) Jewish holidays.
- To promote the welfare of the members of this organization. (e)
- To assist in every way possible the Jewish community. (f) (
- The corporation is organized not for pecuniary profit and is organized exclusively for charitable and educational purposes, included with such purposes are, making of 3. distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding Sections of any future Federal Tax Code.

No part of the net earnings of the corporation shall enter into the benefits, or be distributed to the members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered. No substantial part of the activities of the corporation shall include the counting of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidates for public office. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities or permit activities to be carried on (a) by a corporation exempted from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code or corresponding Section of any future Federal Tax Code, or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code or corresponding Section of any future Federal Tax Code. Notwithstanding any other provision of these articles, this corporation shall not engage in any activity or exercise any powers that are not in furtherance of the purposes of this corporation.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempted purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code or corresponding Section of any future Federal Tax Code or shall be distributed to the Federal Government or to a State or Local Government, for a public purposes. Any such assets not so disbursed shall be disbursed by the Court of the Circuit of the County of which the principal office of the corporation is then located.

  is eligible for membership.
- Application for admission into membership of this corporation shall be in writing as prescribed in the By-Laws.
- 3. The application for admission shall incorporate the within Articles of Incorporation by reference.

#### ARTICLE VI DURATION OF EXISTENCE

The corporation shall have perpetual existence.

#### ARTICLE VII ELECTED OFFICERS AND DIRECTORS
