We, the undersigned, subscribers of these Articles of Incorporation, each a natural person competent to contract, hereby associate ourselves together to form a corporation under the Laws of the State of Florida.

ARTICLE I

The name of the corporation shall be Kilcrease Light Artillery, Inc., a Florida not-for-profit corporation.

The corporate seal of the Kilcrease Light Artillery, Inc. shall be:

**ARTICLE III**  
**Purpose and Objective**

The objectives and purposes of this organization are:

- A. To recreate historically accurate detail Civil War Companies of the historical Kilcrease Light Artillery C.S.A., and Companies of the Forth New York Light Artillery, U.S.A. including uniforms, accouterments, weapons, and equipment, in order to educate and inform the general public of the roles of the historical Kilcrease Light Artillery and the Fourth New York Light Artillery in the American Civil War.
- B. To encourage and promote the study of the history of the American Civil War and particularly the history of the historical Kilcrease Light Artillery, and Forth New York Light Artillery through the presentation of lectures and living history exhibits at various places including, but not limited to, schools, parks, Civil War battle sites and museums.
- C. To participate in historically accurate reenactments of various Civil War battles, and other such public displays, demonstrations, and/or lectures in order to educate and inform the general public. Emphasis will be given to the organization, history, tactics, uniforms, military procedure, drill, music, food, weapons and other equipment of the Union and Confederate Armies, in general, and the historical Kilcrease Light Artillery, C.S.A., and the Forth New York Light Artillery, U.S.A., in particular.
- D. To reflect the highest and best standards of community service and historical authenticity in conduct, dress grooming, and equipment of all members of this organization.
- E. To provide honor guards and color guards in historically accurate Civil War uniforms and equipment for various patriotic and/or military ceremonies honoring American War Veterans, when requested by the sponsoring organization.
- F. To at all times conduct the affairs of the organization within the laws of the United States of America, the laws of the State of Florida, within the limitations of the Articles of Incorporation (Chapter 617, Florida Statutes), and within the limitations of Section 501 (c) (3) of the Internal Revenue Code.
- G. The Kilcrease Light Artillery, Inc. shall be neither organized nor operated for pecuniary gain or profit. Any net earnings of the corporation shall be used to further and enhance the purpose and objectives of the corporation.

**ARTICLE IV**  
**MANNER OF ELECTION OF DIRECTORS**

The manner in which the officers of the directors are elected or appointed are as follows:

1. The Board of Directors will be voted into office at the annual business meeting to be held in May.
2. Directors must be a natural person who are 18 years of age or older.
3. Must maintain a Class "A" membership as set forth in the by-laws of the organization.
4. Must be experience on both 20<sup>th</sup> century artillery and have reenacting experience.

A Board of Directors shall be established to ensure the By-Laws of the corporation are maintained. The Board of Directors shall be established as:

**LIQUIDATION**

Assets held by the corporation upon dissolution requiring return, transfer, or conveyance shall be attended by the remaining Board of Directors.

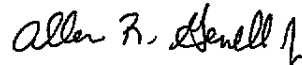
